

On the morning of Saturday 12th April, 300 Designated Persons, Ministers, youth leaders and parents all gathered at assembly buildings to enjoy fantastic cupcakes together but more importantly than that, to consider some difficult issues and learn from experts across various fields. Adjectives such as "Outstanding, On the Nail, Marvellous, Superb!" were used to describe the conference and one delegate commented that it was, "inspiring, educational and fresh". Another wrote," Invaluable – we live in a fast changing world and need to keep up to date and we need to be informed of all topics, especially the difficult ones covered today". The keynote address was entitled, 'Self-harm: The Hidden Harm and the Churches' Response'. Three special guests were interviewed during the 'On the Sofa' section to find out about changes in child protection in areas such as vetting and risk assessment.

# NEW FORMS INTRODUCED

Nothing ever stands still in the remit of protecting children! So once again, a new Access NI form (TCF/14) and a new Garda Vetting form have been introduced. This is to accommodate changes in legislation. The changes are not introduced by the Presbyterian Church in Ireland and we have no choice but to keep up with the law and government bodies. It is envisaged that in both jurisdictions online forms will be available in 2015.

#### ACCESS NI FORMS (NORTHERN IRELAND)

In the last edition of the Update (issue 25) the new definitions of regulated activity were set out. Our new form now incorporates these changes (on the PCI cover page) but was also changed due to filtering. From April 2014, filtering of old and minor convictions and cautions was introduced by Access NI. This means that some minor cautions or convictions will no longer be shown on certificates e.g. a single driving conviction from twelve years ago.

The changes to the Rehabilitation of Offenders legislation to introduce the filtering scheme means that the Presbyterian Church In Ireland as a registered body can no longer ask for details of all convictions. Hence, this question has been removed from the form. The new form is now available to download on our website and available for collection in Assembly Buildings. The previous form, TCF/13 is still being accepted.

#### **GARDA VETTING FORMS (REPUBLIC OF IRELAND)**

In preparation for the commencement of the National Vetting Bureau (Children and Vulnerable Persons) Act 2014, the Minister for Justice and Equality implemented an administrative filter to be applied to all Garda Vetting applications. The purpose of this filter is to allow a more balanced, relevant and proportionate approach to Garda Vetting, pending the commencement of the Act in December 2014. Some minor court convictions are not being disclosed, e.g. motoring offences older than 7 years old.

The Vetting Unit will accept applications on the old form which have been signed by the applicant on or before **11th July 2014**. The Vetting Unit has advised us they "are under legal constraint in this regard and there are issues of liability where a vetting applicant is required to sign a declaration which does not reflect the factual nature of the data being disclosed. Where organisations continue to submit the forms in the old format, liability in this issue will rest with the organisation concerned."

Forms are available on hardcopy from the Taking Care Office. All Designated Persons in the Republic of Ireland were sent a copy of the new form in August.

#### Who completed the Training the Trainers Course?

32 people completed the Taking Care Training the Trainers Course held in May and June of this year at Union College, Belfast and the Glenavon House Hotel, Cookstown. The group is a mixture of trainers who have been delivering the Taking Care material for a number of years – many since 2006 along with several new recruits.

I asked the group the following questions and have included some of the answers:

### What did you think of the Training the Trainer's Course?

"It was an Excellent first time course - well prepared and delivered".

# What did you think of the two days at Union and the guest tutors?

(Guest Tutors spoke on the following topics: The Sexual Offences Law and Sex Offenders; The Role of Social Services; Access NI and the Vetting Process and The World of Insurance and Risk Assessment.)

"Having some external tutors really added to the overall experience of training. All of their presentations were excellent and we learnt a lot from the different speakers which will be very helpful when giving future Taking Care presentations".

#### What did you think of the residential?

"The residential was a great way to get to know the other trainers better and to develop a team spirit amongst the group. It was definitely good to get a chance to present in front of other trainers. PCI investing in a comfortable hotel with food made me feel valued as a trainer".

#### What are the next steps for the course participants?

In order to become a Taking Care Trainer, each participant must successfully complete a Learning Journal and an assessed delivery. This is when they will deliver a Taking Care Training Session and will be assessed by a member of the Taking Care Advisory Group. It is hoped that a graduation event will be planned for December when we can celebrate the achievement of each of the trainers.
