This is a time consuming task and takes Sharon away from her regular work which focuses on





Can I remind Designated Persons to carefully keep letters that are sent from the Taking Care Office regarding the checking of leaders if you do not already? PCI cover sheets should be photocopied and kept alongside letters of appointment sent from the Taking Care Office which should be kept safely and securely on church premises.

# Working Together to Protect Children -

A Common Protocol for churches and independent organisations.


In 2005 representatives from the Church of Ireland, Methodist Church in Ireland, Presbyterian Church in Ireland, along with the Girls Brigade (NI), Boys Brigade (NI), Scout Association and Girlguiding Ulster met to put together an agreed procedure to assist churches that regularly allow independent youth organisations to use their premises and Independent organisations working with children and young people, regularly using church premises for meetings.

This agreement was known as, 'The Common Protocol' and has

been available on the Taking Care website for some time.

The group, who meet regularly, were concerned that little was known about this agreement within congregations and so we decided that a leaflet should be designed and published to explain what the protocol is and how it works.

The colourful and easy to understand leaflet is now available from the Taking Care Office, it is important that all Designated Persons understand the agreement and how it works. Please contact us for a copy of the leaflet.



# **Special focus**Taking Care Audit

The Taking Care Audit took place at the start of 2011. Results were collected between January and May of this year.

The Taking Care Audit took the form of a questionnaire and was sent out to all Clerk of Sessions in November 2010 to be signed by both the Minister and Designated Person. The audit was to be returned by 21st January 2011 although there was some catch up time until the end of May.

At the Board of Social Witness report to the General Assembly this year Taking Care was a main feature. Deborah reported on the results of the audit, although a full report will be available shortly, below you can read what was in the report to the assembly.

### How many audits were returned?

In total, **342** audits were returned out of **518** congregations which is **66%**. This is an improvement from the **2007** Taking Care Presbytery Review for which there was a return of **42%**.

## Where did the figures come from?

The percentages below are based on the **342** audit returns and the figures have been extrapolated to give an indication of what the answers would have been had all 518 audits been returned.

#### **Child Protection Policy**

- **98%** of congregations have a child protection policy.
- 87% of congregations have child protection on their Kirk Session agenda.

### **Designated Persons**

- 99.7% of congregations have at least one Designated Person for Child Protection.
- 86% of Designated Persons have attended training specifically for Designated Persons.

### **Promotion of Taking Care**

- 82% of congregations said that they use the pocket leader's guide 'We care 4 U Too'.
- 9 congregations out of the **342** said that they have held a Taking Care Sunday, as a more recent initiative this is very encouraging. It would be great to hear some feedback from those congregations who have held a Taking Care Sunday, let us know how it went.

#### **Vetting**

We have vetted in the region of **13,851** people.

### **Appointment Process**

- **85%** of congregations ask new leaders to complete an application form.
- **74%** of congregations ask new leaders to provide references.

### **Child Protection Incidents**

There were **302** child protection issues reported to the Taking Care Office in the past five years, issues range from bullying in the youth club to a child disclosing that she had been abused and raped.

### **Taking Care Training**

The number of leaders who have attended taking care training is **16,260**. We are, as a church, indebted to our **26** Taking Care Trainers without whom this would not be possible. The trainers facilitate the training sessions in their own time in a voluntary capacity.

#### Let's Celebrate!

We were very pleased to announce the following figures which demonstrate the extent of the youth and children's work done in the name of the Presbyterian Church in Ireland:

- The total number of youth and children's organisations within the Presbyterian Church is **3,370**.
- The total number of leaders working with children and young people within the Presbyterian Church is **32,964**.
- The total number of children and young people attending PCI youth and children's organisations comes to **119,721**.
