LAUNCH OF WE CARE LEAFLETS

At our recent Taking Care Advisory group meeting, the moderator Rev Rob Craig, launched and endorsed our new 'We Care' leaflets. Three versions of the small leaflets are now available for children and young people, leaders and parents.

The leaflet for children lets them know that the Church cares for them and gives the name and contact details of a key leader within the church they can speak to if they have any problems.

The leader's leaflet highlights the main dos and don'ts concerning child protection based on the Taking Care policy that all leaders have received training in.

The leaflet for parents gives information about the Church's child protection policy and also highlights parents' responsibilities to let leaders know of any special circumstances about their children like allergies or medicines they might require and also the need to keep contact details up to date.

It is advised that when a person becomes a new leader they are given a copy of 'We Care 4U Too'. Congregations are encouraged to decide for themselves how and when they would be best distributing the leaflets for parents and children – perhaps at the start of a Holiday Bible Club or new 'season' of organisations or maybe during a church service such as Children's Day.

Leaflets can be collected from Assembly Buildings in Belfast or from the Taking Care Trainers.



IMPORTANT VETTING INFORMATION

GARDA VETTING MADE LAW (REPUBLIC OF IRELAND)

Garda Vetting is now a legal requirement! Although it has been the policy of the church since 2006, under the National Vetting Bureau (Children and Vulnerable Persons) Act 2012 which was enforced

in March 2013, there is now a legal obligation to vet new leaders who are in regular contact with children. Just a reminder of who that entails.

• 18 years old and over

Leaders who are:

- In new positions of leadership (since 2005)
- Working four or more times a year or an overnight.

If the church appoints new leaders to work with children and young people and they meet the criteria above and does not vet them, they will be breaking the law! Kirk Sessions are reminded to check out that they have vetted all new leaders to date.

FOUNDATION TRAINING

Thank-you to all of our trainers and venues for facilitating the 20 Foundation Training events across all Presbyteries. Thank-you also to all Designated Persons, leaders in charge of organisations and Minsters who have rounded up new leaders and encouraged them to attend.

790 people attended the 20 events, that's a total of 352 new leaders who attended Foundation training in 2013 and exactly 3,000 people since we started the Presbytery events in Autumn 2012! Altogether in 2013 there have been 139 training events -Foundation, Refresher and Social Media.

Here are some comments about the training:

"I was dreading coming this evening but it turned out to be interesting and relevant" (School Teacher).

"I have attended many child protection training through work and the delivery and information given tonight was excellent" (Senior Social Worker).

ACCESS NI -GET YOUR FORMS IN OUICK!

Access NI have changed their policy to state that an applicant's signature must be dated within three months of when they receive the form from the Taking Care Office. Obviously we need to allow time for the form to be sent from the Taking Care Office to Access NI. Therefore if the date of signature on the form is more than two months ago when it reaches the office, there is a risk that the form will be returned. Designated Persons are advised to send each form to us as soon as it has been completed and checked.

TAKING CARE FOR MINISTERS

Child Protection Training for Ministers as agreed by the General Assembly has been organised for 2014. This training is for all active Ministers (including Assistant Ministers who are eligible for a call in 2014 and active retired Ministers currently working in a congregation).

Events held in Northern Ireland will differ to those in the Republic of Ireland in terms of legislation. Therefore Ministers should attend the event in the jurisdiction that the majority of their congregation live in. For a list of dates and venues please contact the Taking Care Office.

DATE FOR YOUR DIARY

The Taking Care Conference 2014 has been arranged for Saturday 12th April. The keynote speaker will be Cathy Bell, regional co-ordinator of Independent Counselling Service for Schools. Cathy also serves on the board for the Big House, Ireland. Cathy will be addressing us on the subject of self-harm. an issue affecting an increasing number of young people today.
