## Changes to Legislation (N.I)



The Safeguarding Vulnerable Groups Order (NI) 2007 was amended by The Protection of Freedoms Act 2012. As a result of this, there are two changes that Designated Persons and those in church leadership need to be aware of:

- 1. A slight change to the answer to the popular question, "Who should be checked?"
- 2. A legal duty is placed on organisations to refer people deemed 'unsuitable to work with children or vulnerable Adults due to risk of harm' that they may pose to the Disclosure and Barring Service.

I will briefly outline what these changes entail for us below:

 Access NI checking has always been for those working/volunteering 'regularly' with children (i.e. under 18 years old) but it was never stipulated by the government what 'regularly' actually mean, hence we decided that regular would mean four or more times a year. This change in legislation does define for us what they call regulated activity and it is the following:

Those involved in unsupervised roles: teaching, instructing, caring for or supervising children/young people, providing guidance on well-being or driving a vehicle -

- Once a week or more
- Four or more times in a 30 day period
- Any overnight

Guidance in the form of a downloadable leaflet will be produced over the next month or so to make clear how all of our organisations and roles fit into this and to ease confusion. What is important to note is that **nobody needs to be re-checked** and most organisations will not be affected by the changes. It will mostly be those that operate on a rota basis that might be affected.

2. If any organisation or congregation removes a person from a position of leadership with children because they have caused harm or have the potential to cause harm they must contact the Taking Care Office as the Disclosure and Barring Service will most likely need to be informed.

## TAKING CARE CONFERENCE 2014

12th April is our Conference date and this year our keynote is not to be missed. During 2013 the Taking Care Office dealt with 42 child protection incidents, 9 of these were reports of young people self-harming.

However, the number of young people in our congregations affected by self-harm will be much, much more. Cathy Bell brings a wealth of experience from both a professional and Christian perspective as she considers this 'hidden harm' and what the response of the church should be.

With 10% of young people in Northern Ireland having self harmed (statistic from 'The Big House, Ireland') and NSPCC citing a 50% increase in contacts mentioning self-harm among 12 year olds, if you've haven't come across this issue yet, there's a good chance it will cross your path at some point. If you can't make the conference date, encourage someone else from your church to attend. If you can, I look forward to seeing you there!
