### Intermission

The Report of the **COUNCIL FOR SOCIAL WITNESS** (Reports pp359-374) was submitted by Mr Lindsay Conway, OBE.

Moved by Mr Lindsay Conway, OBE, seconded by the Rev PE Dickinson, and agreed:

- 1. That the General Assembly give thanks to God for the opening of Trinity House, Garvagh and for the efficient transfer of the work and witness of Ard Cluan (Londonderry) and York House (York House).
- 2. That the General Assembly note the launch of the Adult Safeguarding Policy, Guidelines and Pocket Guide on 15th March 2018 and encourage congregations to use the resources and avail of appropriate training.

- 3. That the General Assembly, recognising the under provision of support services for those with a Learning Disability in the post-19 age group, encourage the Council for Social Witness as it explores this matter and, if appropriate, engages with the Department of Health in collaboration with the Council for Public Affairs.
  - 4. That the report of the Council for Social Witness be received.

# GENERAL COUNCIL SECTION 5 – lapsed item commenced (see page \_\_\_\_)

**Section 5** of the Report of the **GENERAL COUNCIL** (Reports pp114-142) along with resolutions 33-38 (Reports pp146-148) was submitted by the Rev Dr JA Curry, together with the following Supplementary Report:

### **AD-HOC BUSINESS**

- 1. During the last year discussions have taken place to seek a resolution to what might be described as a small, but significant, anomaly in the current Code. This is to do with the wording of Par 226, relating to the provision whereby a Minister who is unable to remain in his/her charge to the normal retirement date may apply to be designated Minister Emeritus of the congregation(s) they are leaving. This enables the Minister to be a full member of Presbytery and General Assembly. Reference is made to these discussions in paragraph 7 on page 69 of the 2018 Reports.
- 2. The current provision of Par 226 of the Code relates to Ministers who 'voluntarily resign' from their charge, and the Moderator's Advisory Committee has outlined the process to be followed for such to be considered by the Assembly (see 2018 Reports pages 69 & 73). However the current wording of the Code does not make similar provision for a Minister who, near to retirement, is loosed from his/her charge and where there is no fault (e.g. under Code Par 318(3)(c)). An overture has therefore been drafted, and is included on page 154 of the 2018 Reports, to enable the Assembly to consider amending the Code so that such Ministers may come within the scope of the provision made in Par 226.
- 3. The Presbytery of North Belfast, having been an advocate for such a change and having been made aware that the 2018 Assembly would be considering that change, has requested that the Rev Jack Drennan would be able to avail of this new provision, if of course the change to Par 226 is

agreed by the Assembly. Mr Drennan was loosed from his charge, to facilitate a realignment of ministry, on 1<sup>st</sup> February 2016, becoming then a Minister without Charge.

4. This request has been considered by the Moderator's Advisory Committee, on the basis of the agreed guidelines, and the Committee is supportive of the request. A suitable resolution is appended, which will be competent only if the 2018 Assembly has earlier amended Par 226 through the overture referred to above.

### **Additional Resolution:**

37(a). That, under Par 226(a) of the Code, the Rev JSB Drennan be enrolled as Minister Emeritus of the congregation of Crumlin Road, Belfast.

  - (f) the resignation of Mr John Hunter, CB, as Convener of the Support Services Committee, that he be thanked for his services, and that Mr David Thomson be appointed in his place.

- (g) the resignation of the Rev DJ Irvine as Convener of the United Appeal Committee on 2nd February 2018 be noted, that he be thanked for his services, and that the Rev MR Catney be appointed in his place.
- (h) the resignation of the Rev JN Seawright as Convener of the Older People's Services Committee, that he be thanked for his services, and that the Rev JNE Reid be appointed in his place.

The Moderator paid tribute to those Conveners retiring at this Assembly, and received those present in the House. He then led in prayer.

- 36. That the nominations to the General Assembly Commissions, Councils and Committees (as tabled by the Nominations Committee) be approved.
- 37. That the General Assembly to approve that the term of service for Council and Committee members be four years from the Assembly of appointment, rather than for the remainder of a general four year term.

    - (a) That the suggestion of an interim, follow up event to the 2017 Special Assembly should not be pursued.
    - (b) That in early 2021, a Task Group, comprised primarily of members of the Priorities Committee and the Council for Congregational Life and Witness, be formed to prayerfully discern if there is an emerging theme for a residential Special Assembly to be held in 2024.
    - (c) That should such a theme obviously present itself to the Task Group, that a recommendation be brought to the 2021 General Assembly for a Special Assembly in August 2024 and suitable arrangements for delivery of such an event be set in place.
    - (d) That if such a theme does not obviously present itself to the Task Group, that no Special Assembly be held in 2024, but that the matter of future Special Assemblies, or alternatives, be considered by the General Council.
- 39. That the General Assembly agree that the new structures for the Council for Congregational Life and Witness (see pages 136-142) become operative from the 2019 General Assembly.

Moved by the Rev NSR Lockhart, seconded by Mr Trevor Long, OBE, and agreed:

40. That, under Par 226(a) of the Code, the Rev JSB Drennan be enrolled as Minister Emeritus of the congregation of Crumlin Road, Belfast.

41. That Section 5 of the Report of the General Council be received.
